Legacy 505 Hazloc Listings

Issue

The legacy Woodward 505, including the base 505, 505 Enhanced and 505E, no longer meet the requirements for ATEX listing. This also means the loss of ATEX-derivative listings including C-Tick, EAC, and CU/GOST-R. Markings for ATEX and derivative listings will be removed from the product. Manuals and other documentation will be modified accordingly.

Other listings including North American Hazardous Locations are not affected. Legacy units will continue to carry the CE mark

Description

The legacy 505 products released in 1998 have been replaced by the new 505D and 505XT. Our European Notified Body has informed us that the legacy versions no longer meet the requirements of European Hazardous location (ATEX) listings. The legacy versions are at the end of their product lifecycle and we are asking those customers who need ATEX to convert to the new 505 products.
