Product Change

The TecJet 52 using the F-Series 35-pins actuator has been an important offering from Woodward for many years that Woodward had supported through many rounds of obsolescence management. Due to the volatility of the semiconductor supply chain market, declining demand for non-RoHs components, and an already available RoHs compatible solution (100% backwards compatible), the non-RoHs versions are being inactivated.

Product Support Schedule

Woodward will continue to fully support the product while under its original factory warranty.

Replacement Options

The TecJet 52 (generation 2) RoHs variant is 100% compatible with the current non-RoHs versions.

Customer Action

Prior to December 31, 2023, contact your local Woodward representative for Last Time Buy opportunities OR to discuss available upgrade/migration products.

Woodward strives to hold inventory or look for alternative parts when components that are actually used are no longer available.
