



Woodward Legacy Fuel Valves 3103/3171

Product Change

The Woodward 3103 and 3171 Fuel Metering Valve family used primarily for industrial gas turbines are being removed as a standard product offering. Woodward's newest GS40 and GS50 Series Fuel Metering Valve family will replace these legacy product lines with superior performance and reliability.

Description

Woodward will stop shipping these products on September 30th, 2026. Please contact your Woodward representative for current lead time and last time buy opportunities. Woodward will offer repair and overhaul services for these items until September 30th, 2037 (based on component availability) along with full support for the product while under its original factory warranty.

The GS-Series is designed with flange-to-flange compatibility with the 3103 to simplify installation, while offering modern enhancements that elevate performance. Unfortunately, Woodward cannot offer a direct replacement option for the 3171. If you're considering transitioning from the 3103/3171 to the GS-Series Fuel Metering Valves, please contact your Woodward representative to discuss packaging and control considerations that may influence your migration strategy.
